

FAMCAMP INFORMATION

Authorized Personnel

The use of **FAMCAMP** facilities is restricted to active duty/retired military personnel (DOD civilians, inactive reserves and National Guard personnel are authorized use of facilities on a day-to-day space-available basis.)

- Camping time limit is **60 Days** from 1 Nov. to 1 Mar.
90 Days from 1 Mar. to 31 Oct.
- Site rent must be paid on time; a late charge of \$5.00 per day shall be added to the daily fee.
- Notification of an evacuation, **all RV's** and personal items **must** be removed from FamCamp property.
- Use of the **FamCamp** facilities is restricted to registered campers and their guests. A maximum of 4 guests is permitted between 0800 –2200.
- Children under the age of 16 must be accompanied by and adult at all recreational areas of FamCamp.
- The **SPEED LIMIT IS 10 MPH**, please observe.

Restrictions:

- Clotheslines are prohibited
- No disabled vehicles allowed
We do not provide a “Valet Service” if you cannot drive it or tow it, don't bring it.
- No ground fires or fireworks are allowed.
- No swimming in adjacent water.
- Smoking is not allowed inside facilities.
- Use of the kitchen in the recreation building is limited to supervised FAMCAMP functions.
- The use of hazardous chemicals on Tyndall AFB, FamCamp property is strictly forbidden

Campsite checkout is 1100 hrs:

- Any delays in departure after 1100 will result in a fee of one(1) day rental on that site
- Prior to checkout **please remove all trash and Pet “droppings”** from campsite and deposit in provided dumpsters.

A copy of the Operating Instruction is available upon request.

The following pet rules are strictly enforced:

Pets are not permitted in or around FAMCAMP rental cottages.

Dogs and cats must be on a leash. Pets may not be left unattended and tied up outside at picnic tables, RV, trees or similar areas.

No pets are permitted inside the recreation building, bathhouse, gazebo, or play areas.

Pet owners will ensure their pets do not disturb other campers (constantly barking dogs).

Good behavior is required. Pets of any breed that are hostile or aggressive will be asked to leave the campground, along with their owners.

All pet droppings will be picked up immediately, bagged and properly disposed of in the trash dumpster (this includes the dog walk areas and dog park).

NOTE: Patrons failing to comply with pet rules will be requested to remove their pets from the FAMCAMP area immediately without further notice. Patrons will not feed any stray animals in the FamCamp. Stray animal locations are to be reported to the office ASAP.

Cottage Registration And Guidelines:

Cottages may be reserved 90 days in advance. Reservation requires a \$75.00 deposit, either with credit card, cash, or a check mailed within 10 days after call is placed. Refunds can be made for cottages only if cancellation is within 10 days of the reservation. Patrons will be informed immediately that they are responsible for care and cleanliness of cottages and supplying their own linens and towels.

Upon arrival the patron is requested to fill in a registration card as well as a cottage check sheet with the inventory and condition of the cottage. This check sheet is to be returned to the office and signed by the Rec aide on duty, a copy will be then be given to the patron with the 2 carbon copies staying at the office until check out. The refunding of the \$75.00 deposit will be accomplished after the staff member has inspected the cottage. Damages or removed inventory will result in loss of refund.

There will be no pets, no smoking, and no open fires allowed in or around the cottages. All camping rules stated for campers will also apply to cottage residents.
